# General Instructions

- GQG will accept Entries starting **December 1, 2010** and will accept no Entries arriving after **2:00 p.m. PST January 7, 2011**. If you have questions, please contact the Acquisition Chair prior to the closing date.
- Rule 1:** All Entries submitted for competitive judging must have been completed NO MORE THAN TWO YEARS PRIOR to the Show.
- Membership in the Glendale Quilt Guild is not a requirement for Entry. However, some Categories are limited to Glendale Quilt Guild Members.
- Non Guild Members must pay a \$10.00 entry fee for each Entry.
- You may enter only three (3) quilts. Each quilt must be in a different category. Due to space limitations, we may ask you to show fewer quilts.
- Exhibits need not be the work of the person(s) submitting the Entry.
- A quilt made from a kit may be judged for feedback but is not eligible for an award. A quilt kit is a published pattern with fabric that is sold commercially as a single item.
- Each quilt must have a label affixed to the back of the quilt with the name of the quilt, Entrant's name, address, and phone number. This Identification Label must be completely covered with either tape or muslin.
- Each quilt must have a four (4) inch hanging sleeve along the top edge of the quilt.
- Submission of an Entry Form does not ensure acceptance of an Entry in the Show. GQG reserves the right to decline to exhibit any Entry for any reason.
- Judges and GQG Show Committee rely on the accuracy of the information provided by Entrant(s) when bestowing awards.
