The planning has already started for **Glendale Quilt Guild's 32nd Annual Quilt Show** at the Marriott Burbank Convention Center, 2500 Hollywood Way, Burbank CA 91503. The dates are March 18-20, 2011

The theme of the 2011 show is "Quilts of the Wild West." Quilts, wearable art and doll exhibits will be on display. Show events include workshops, opportunity quilts, special events and carloads of quilters and shoppers!

If you have never attended our show, the Vendor Mall is an essential part. The quilt show hours this year are: Friday, 10- 5, Saturday, 10-5, and Sunday, 10-4. We like to offer a wide variety of merchants for our attendees shopping enjoyment, but our exhibit space is limited. Our goal is to select a blend of vendors who have traditionally participated in our show and our shoppers have come to expect to see when they attend, along with new vendors who can bring innovative new products and projects to the Vendor Mall. Some of our most successful vendors have unique products and fun demonstrations. Also, if selected we encourage you to contact the teachers and ask if there are supplies you can have on hand for their class participants.

We ask our show vendors to donate a door prize. Door prizes will be collected on Friday morning. This year the door prizes will be used for the daily "Shopper's Reward" drawing. Shoppers will receive a raffle ticket for each \$25 in purchases. At the end of each day a raffle ticket will be drawn for a basket of prizes.

Another incentive for the 2011 show exclusively for vendors is a special stay 3 nights, pay for 2 if you stay in a standard room at the Burbank Marriott during our show. The nightly rate will be \$105/night + tax and fees.

Width x Length
